Rt 153 Annual Beach Clean Up

On Saturday, August 25, the Fifth Annual Province Lake Beach Cleanup took place. Twenty people participated and in the course of an hour and half, they collected 2,134 separate items weighing 160 pounds with cigarette butts and firework debris the most numerous items. This debris was disposed of at the Town of Effingham Transfer Station. Once again, a successful clean up will go a long way to helping keep the beach clean.

Cyanobacteria Update

Province Lake experienced a cyanobacteria outbreak from August 6 to August 16, when the DES lifted the Advisory. Please stay vigilant and if you suspect a cyanobacteria bloom is occurring, please call the NH DES CYANO hotline immediately at **(603)** 848-8094, or (603) 271-0698 (Amanda McQuaid), or email beaches@des.nh.gov. You can also use the bloomWatch app to send a photo. Please also call the PLA at 207-200-3243 so a sample can be obtained. Advisory signs will be posted when the NH DES issues an Alert. Phosphorus Study

As we mentioned in previous newsletters, the PLA with the Acton Wakefield Watersheds Alliance (AWWA), NH Department of Environmental Services and DK Water Resource Consulting LLC is conducting a study through 2019 to collect and analyze data to better understand the phosphorus loading in our lake and how it may be impacting our water quality. Phosphorus is thought to be a trigger nutrient for cyanobacteria and algal blooms and loading is a measure of how much phosphorus is available to feed these blooms. A monitoring plan has developed and sampling is ongoing.

Core samples of the lake bottom sediments will be taken. These samples will then be analyzed to ascertain the levels of phosphorus and other constituents in the bottom sediments.

Water samples are being taken at 7 stations around the lake. The samples will be evaluated for soluble reactive phosphorus and total suspended solids. Deep (14ft) and shallow (5 ft) samples will be taken. Water sampling will be done after busy boating periods on the lake to understand how that activity may resuspend phosphorus-bearing sediments into the water column. Water sampling will also be done after significant wind events, again to see if the wind is resuspending bottom nutrients.

Once the sediment and water samples and their analyses are complete, the data will be incorporated into a model that should help quantify how phosphorus is impacting our water quality. The model may help determine what actions could be taken to mitigate phosphorus resuspension and potential cyanobacteria blooms in the lake. Preparing Your Lake Property for the Winter

Thank you to the Maine Department of Environmental Protection for providing this useful information.

Yes, sadly the time is coming to prepare your lake property for the winter. The summer months have flown by. It seems like just yesterday you were opening up your cottage for the summer. It is now time to get the cottage ready for the harsh fall and winter months ahead. When going through this yearly winterizing ritual, it is important to consider possible impacts to lakes and wildlife from these activities. The following are some tips to help you in doing this:

- **Drain Pipes** Winterizing a cottage requires preventing pipes from freezing. Drain the water system to ensure that it won't freeze, **do not** use anti-freeze to protect plumbing. Antifreeze is toxic and it poses a threat to ground and surface waters, not to mention the danger of it being ingested by pets. Adding *antifreeze to plumbing fixtures is not necessary* provided all the fixtures are completely drained.
- Protect from rodents Damage from rodents such as mice and squirrels are also a concern for cottage owners. Refrain from using pesticides or poisons. To prevent these unwanted guests, inspect the cottage inside and out to make sure there are no openings for rodents to enter.
 Remove all food sources from the cottage before you close it.
- Check for erosion To make sure that shorefront areas will not succumb to ice or wave
 damage, inspect the shoreline thoroughly. Stabilize any eroding areas with plants or rock riprap
 if necessary. If using riprap, patching a retaining wall, or doing anything more than minor
 maintenance and repair, state and local permits are required, so plan accordingly. This is also a
 good time to inspect parking and landscaped areas for signs of erosion.
- Remove dock When removing docks and boats from the water try to store them in an area
 that will not kill vegetation. A stable shoreline and healthy vegetation are important in keeping
 eroding soil from harming water quality.
- **Boats** Do not try to drain gasoline from fuel tanks of outboard motors or other power equipment. Instead, use fuel stabilizer (available from your dealer or auto parts store) to keep fuel fresh for next season. Winterize your engine(s) away from the water. When changing lubricating oils, collect the oil and bring it to your dealer or a recycling facility for proper disposal (see oil recycling list for locations). Wash boats away from the water, preferably at a commercial car wash. Many detergents and motor oils contain chemicals that can pollute the lake and harm fish.
